1 Briefly describe the organization's mission: AALEAD supports low-income and underserved Asian Pacific American youth with educational empowerment, identity development, and leadership opportunities through after school, summer, and mentoring programs.

(Revenue \$) DC Elementary School Program: AALEAD provides high quality academic enrichment programs at two DC Elementary, Bancroft ES and Thomson ES, and in FY14 provided a full-day five-week summer program which served 75 students at Thomson ES. Our program components include, but are not limited to, homework help, field trips, and enrichment activities focused on exploring culture and identity, building leadership skills, and completing community service. Past enrichment activities and field trips have included "country studies" where students spend time examining different aspects of a region's culture, lessons on developing and practicing leadership skills, and discussions of career goals. Field trips have included taking part in a park clean-up and participating in Fiesta Asia, an annual street festival celebrating

4b (Code:) (Expenses \$ 108,647. including grants of \$ 463.) (Revenue \$) DC Middle & High School Program: AALEAD's DC Middle & High School Program serves youth at two community based sites - one in Mt Pleasant and one in the Chinatown neighborhood. The program meets two days after school each week and provides a safe community where students can learn about Asian American culture, explore their own identity, practice leaderships skills, and receive guidance about school, career paths, and college. Activities include community service, leadership workshops, cultural activities, and field trips. As part of the FY14 summer program, DC Middle and High School students collaborated with MD AALEAD youth to put on our 3rd Annual Asian Pacific American Youth Summit, which was planned by youth for youth.

4c (Code:) (Expenses \$ 230,333. including grants of \$ 31.) (Revenue \$) MD Middle School Program: In FY14, AALEAD served 142 youth at Loiederman, Argyle, Eastern, Parkland, and Newport Mill Middle Schools in Montgomery County, MD. Youth learned about Asian American cultures, developed leadership skills, accessed school resources, and provided service to their community. Specific activities include cooking workshops highlighting an Asian country, counselor and teacher panels, and field trips to organizations like Manna Food Center to provide service. In FY14, 98% of middle school youth participated in at least 5 Asian American focused activities. During the summer program, youth focused on the theme of mental health by discussing ways to handle stress and the stigma on mental health in the Asian American community, among others.

Vision: AALEAD envisions a United States in which low-income and underserved Asian Pacific American youth, and youth of all backgrounds, are equipped with the tools and opportunities to define themselves and their own futures.

Asian and Asian Pacific Islander cultures. In FY14, 100% of our Elementary School students passed on to the next grade level.

MD High School Program: The MD High School Program served 53 youth at Einstein, Blair, and Wheaton High Schools. During the summer, high school youth mentored, taught, and built relationships with our middle school youth. They also planned and hosted our 3rd Annual Asian Pacific American Youth Summit in July 2014, where youth from the community were invited to engage in workshops around activism, stereotypes, bullying, and spoken word, among others.

VA High School Program: AALEAD officially expanded into Fairfax County,

expansion of our Mentoring Program. The AALEAD VA High School Program launched in fall of FY15 (October 2014) and currently serves 26 youth. In FY14, AALEAD staff met with youth from Annandale High School once a week during lunch and engaged youth with ice breakers and team-building activities to build community and learn about AALEAD. Youth had the opportunity to participate in our Annual DC Park Clean Up, Fiesta Asia (cultural street festival), organizational strategic planning, and staff hiring process.

Mentoring Program: In FY14, the Mentoring Program served more than 75 pairs across the greater DC Metro area. The AALEAD Mentoring Program matches Asian Pacific American youth between the ages of 10 and 18 with caring adults who support them in developing the academic and life skills necessary to succeed. Mentors meet one-on-one with their mentees and engage in activities in their local community. Mentors must be 21 or older and must be committed to meeting with their youth for a minimum of 6 hours a month for one year. Past outings have included museum and college visits, community service events, academic support, trying new foods, and spending time together, among others. AALEAD trains each mentor and supports mentors and mentees through regular field trips and community service activities that bring pairs together for fun and encouragement.


