1 Briefly describe the organization's mission: AALEAD supports low-income and underserved Asian Pacific American youth with educational empowerment, identity development, and leadership opportunities through after school, summer, and mentoring programs.

4a (Code:) (Expenses \$ 340,096. including grants of \$) (Revenue \$) DC Elementary School Program: In FY15, the AALEAD DC Elementary School Program continued to strengthen its partnership with two DCPS school sites during the academic school year- Thomson Elementary School and Bancroft Elementary School. 89 youth were served through the after-school program, which was offered five days per week for 2.5 hours per day. Youth in grades PreK- 5 received academic support and homework-help focused on developing mathematics and literacy skills. In addition, program teachers offered daily workshops to enhance each students' knowledge of careers, cultures, and leadership. Several elementary school youth were elected to Youth Council positions, where they served as youth leaders and provided input in AALEAD programmatic decisions. The DC Elementary School Program served a diverse group of

(Revenue \$) DC Middle & High School Program: In FY15, AALEAD's DC Middle & High School Program served youth at two community based sites in the District of Columbia- one in the Mt. Pleasant neighborhood and one in the Chinatown neighborhood. Programming took place two days per week after school at each program site. Youth were provided with a safe and nurturing environment to learn about Asian American culture, explore their own identity, practice leaderships skills, and receive guidance about school, career paths, and college. Activities included community service, leadership workshops, cultural activities, and field trips. As part of the FY15 summer program, DC Middle and High School youth took part in a STEM-based curriculum that focused on technology, entrepreneurship, and workplace professionalism. Participants in the

4c (Code:) (Expenses \$ 232,106. including grants of \$ 133.) (Revenue \$) Maryland Middle School Program: In FY15, AALEAD served 139 youth at Loiederman, Argyle, Eastern, Parkland, and Newport Mill Middle Schools in Montgomery County, MD. Youth learned about Asian American cultures, developed leadership skills, accessed school resources, and provided service to their community. Specific activities include cooking workshops highlighting a specific Asian country and its cultural history, counselor and resource teacher panels, and field trips to organizations like A Wider Circle to provide service. In FY15, 90% of middle school youth participated in at least five Asian American focused workshops or activities. During the summer program, 50 middle school youth focused on the theme of mental health by discussing ways to handle stress and the stigma on mental health in the Asian American

90% of youth participated in at least three leadership workshops with AALEAD. During the summer program, high school youth mentored, taught, and built relationships with our middle school youth. The theme of the summer program was health and service. The MD high school youth also planned and hosted our 4th Annual Asian Pacific American Youth Summit in July 2014, where youth from the community were invited to engage in workshops around activism, stereotypes, bullying, and spoken word, among others.

Virginia Middle School Program: As part of AALEAD's strategic plan to serve more youth in the greater Washington DC metro area, programming was developed at the middle school level in Fairfax County, VA, in FY15. Through the support of school administrators and staff members, two brand new programs were launched at Edgar Allen Poe Middle School and Holmes Middle School in the city of Annandale. These two middle schools feed into Annandale High School, where AALEAD programming already exists, and it creates a wonderful opportunity for youth to receive services over a longer period of time. Youth participated in programming at their school sites two days per week for 2.5 hours each session.

Virginia High School Program: The VA High School Program had a very successful transition from a lunch-time program in FY14 to a full after-school program in FY15. Since the VA High School Program was still relatively new to Fairfax County, VA, AALEAD staff met with youth from Annandale High School twice per week after-school and engaged youth with ice breakers and team-building activities to build community and learn about AALEAD. This proved to be very helpful, as enrollments

grew to 30 youth in its second year of implementation. Youth had the opportunity to participate in our Annual DC Park Clean Up, Fiesta Asia (cultural street festival), organizational strategic planning. During the summer, several youth help with the planning of the 4th Annual APA Youth Summit, a conference hosted by youth for youth to highlight and discuss solutions for issues facing the Asian Pacific American youth community.

Mentoring Program: In FY15, the AALEAD Mentoring Program served 75 mentor-mentee pairs across the greater DC Metro area. The Mentoring Program matches Asian Pacific American youth between the ages of 10 and 18 with caring adults who support them in developing the academic and personal skills necessary to succeed. Mentors meet one-on-one with their mentees and engage in activities in their local community.

Mentors must be 21 or older and must be committed to meeting with their youth for a minimum of 6 hours per month for one year. Past outings have included museum and college visits, community service events, academic support, cultural exploration through food, and spending time together, among others. AALEAD trains each mentor and supports mentors and mentees through regular field trips and community service activities that bring pairs together for bonding and encouragement.
